# What is ISO 45001?



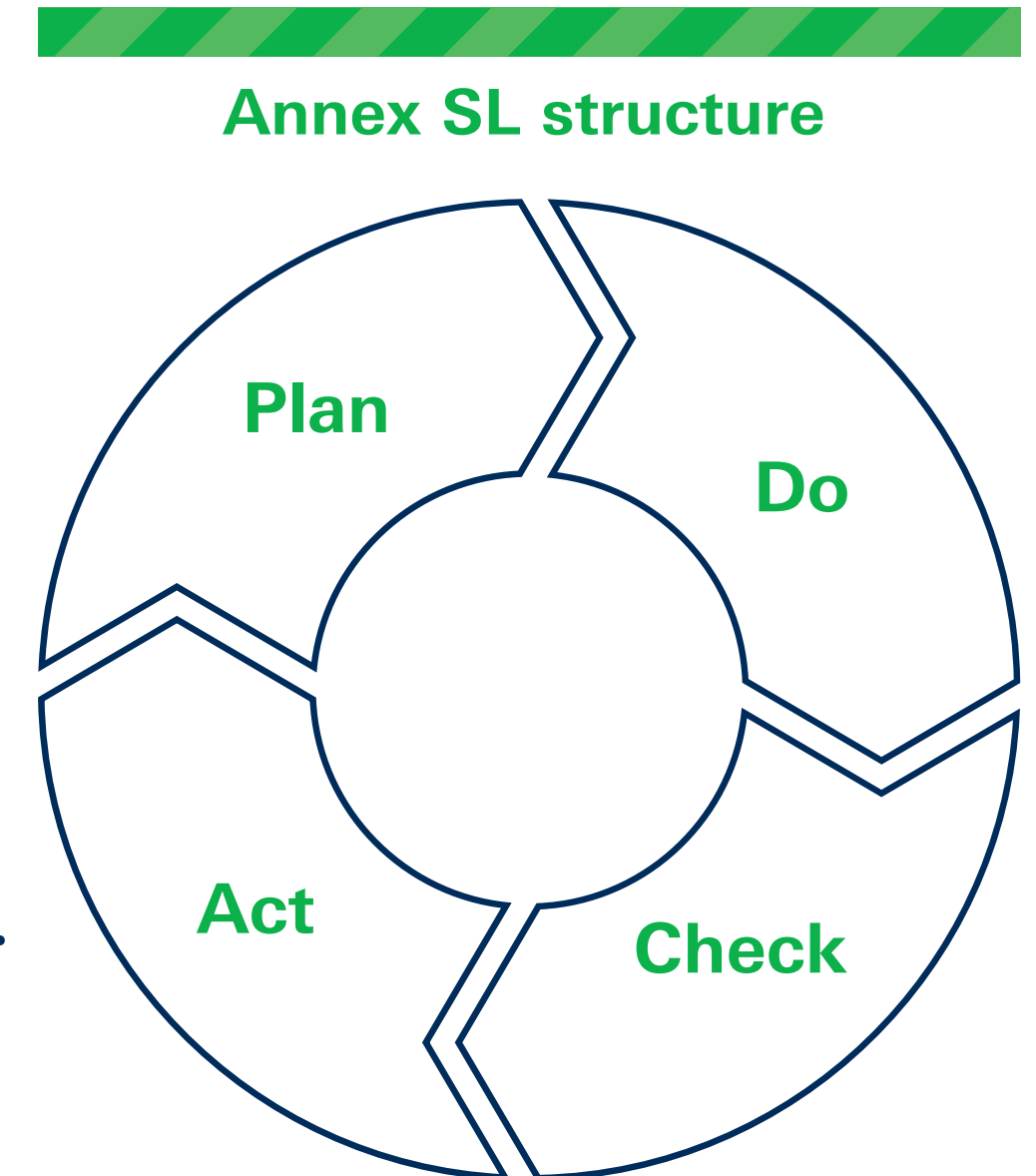
ISO 45001 is the **first international OH&S management system standard**. It aligns with the Annex SL high-level structure used in ISO 9001 and ISO 14001.
